Provenance: These records were created by the First Unitarian Society, the Church of the Good Shepherd, the First Universalist Society, and the Church of the Good Shepherd Unitarian Universalist. They were donated to the Lawrence History Center by the Unitarian Universalist Congregation of Andover, MA on September 18, 2002.

Historical Note: In 1847, Charles Storrow, who would become the first mayor of Lawrence in 1853, called on those in Lawrence with the view of organizing a Unitarian Society. The First Unitarian Society of Lawrence, MA was founded that same year. Hezekiah Plummer erected the church building around 1849-50 on the corner of Haverhill Street and Jackson Street. The church was reorganized in 1878, and several new departments and programs were developed. These included a department of public worship and instruction, a Sunday School, and many new groups that provided a more social and literary culture. Among the various new groups at the First Unitarian Society were the Lawrence Branch Alliance and the Unity Club. The Lawrence Branch Alliance held sewing meetings during which members would sew clothing for the Red Cross, and the Unity Club held many literary and social events. Among these events were "Studies in American Literature," "Phases of Current Thought," and "Studies in the Elizabethan Period." In 1917, the church, for unknown reasons, had to be torn down and the parish was able to obtain full property rights from the Essex Company, which allowed them to build a new chapel.

In 1848, the First Universalist Society was founded. At first the members worshipped in halls and school houses, but after nineteen men signed promissory notes of five hundred dollars each the Universalists were finally able to build a meetinghouse on Haverhill Street in 1853. In 1865, the building was remodeled and enlarged, however the spire was damaged in 1954 during a hurricane. Within the First Universalist Society there were many groups, such as the Church Union and the Young People's Christian Union. The Church Union would often donate money to

the families of ill members and to different organizations in Lawrence, including the Lawrence Boys Club, the Lawrence City Mission, and the Lawrence Home for the Aged. The Young People's Christian Union would often help with or sponsor social events for the Lawrence community, such as Halloween Hayrides and the State Ball, which was held in Lawrence.

In 1859, the Church of the Good Shepherd Universalist was formed from within the First Universalist Society. There were many groups in the Church of the Good Shepherd. These included the Alliance of Universalist Women, which often held sewing meetings where they would sew clothing for the Lawrence General Hospital, and the Men's Club, which would assist in various community events, such as clothing drives for the hungry and blood banks. In 1943, the Church of the Good Shepherd and the First Universalist Society formed a single organization, known as the Church of the Good Shepherd of the First Universalist Society, which occupied the church on Haverhill Street. Organizations within these two churches merged: the Mission Circle from the Church of the Good Shepherd and the Mission Circle, Church Union, and the Florentia Club from the First Universalist Society became known as the Association of Universalist Women. The First Unitarian Society joined in union services with the Church of the Good Shepherd of the First Universalist Society beginning in 1954. This proved so satisfactory for both parishes that, in 1956, the churches merged and became collectively known as The Church of the Good Shepherd Unitarian Universalist of Lawrence, Massachusetts. The Unitarian Universalist Church continued to be located at 201 Haverhill Street until 1996, when the city of Lawrence bought the property. This location is now occupied by the Evangelical Methodist Church of Lawrence. The Unitarian Universalist Church then moved to Andover, Massachusetts.

Scope and Content: This collection includes the records of the First Unitarian Society, Church of the Good Shepherd Universalist, First Universalist Society, and the Church of the Good Shepherd Unitarian Universalists. The majority of these records are composed of meeting minutes, constitutions and bylaws of various church committees and groups, financial records (including account books), treasurer reports, and invested funds. There are also facilities records (including information on the construction of the churches), member lists, and vital records (including birth, baptism, marriage, and death records). The collection also includes the churches' constitutions and bylaws, correspondence involving the various churches, including Reverend William Joplin, one of the founders of the First Universalist Society and Reverend George Clark, the first pastor of the First Universalist Society, and member transfer requests and correspondence between the churches regarding the merger of the Unitarians and Universalists.

Subseries 2: Financial, 1852-1951

This subseries contains account books, check registers, and receipt and expenditure records of the First Universalist Society. One account book was used before and after the merger of the Church of the Good Shepherd and the First Universalist Society. There are also investment fund records, including detailed information regarding the money contributed to the Lucey Storrow Fund. There are financial reports given by the treasurer and payment letters of members, records of payment given to Reverend George Clark by various members, and mortgage release documents. There are also the records of the Special Relief Association, which was created as a means for the First Universalist Society to extinguish their debt. Among the records of the Special Relief Association is a roll of honor of subscribers, which was signed by the members who were in agreement to end the debt of the Society.

Subseries 3: Membership, 1852-1917

This subseries is composed of documents regarding memberships, including member meeting notices, which were written to inform members of upcoming meetings. There are also church and committee member letters of resignations and documents regarding the deaths of George H. McFarlin and Henry Buell, both of whom were members of the church. The subseries also includes information regarding Summer Needham, who was one of the first Union casualties of the Civil War, and a court summons for P. Gage to pay \$100 to B. Griffin. There is a Charles Storrow memorial placard, another placard of the "first martyrs of the Civil War" from the Lawrence Civil War Memorial. The latter shows the men in the Sixth Massachusetts Militia, which took part in the Baltimore Riot on April 19, 1861. These men are considered to be the first casualties of the Civil War and were originally from Lawrence.
